PADS software should not be run from Windows Server, but you can install the libraries and share them for group use across a local area network (LAN). We do not recommend use of shared libraries across a wide area network (WAN) due to issues with latency.

Support for some hardware keys (dongles) discontinued as of PADS VX

The Pink (SSI) and CPLUS parallel port keys are no longer supported starting in PADS VX and in following releases. Other parallel port keys are also affected by this change depending on the Windows Operating System. To swap your existing parallel port hardware key for a USB hardware key, refer to TechNote MG577871 for details.
